




STATE OF CHRONIC DISEASE IN LOUISIANA



Health care disparities create undue and significant hurdles for patients in need and disproportionately impact individuals with chronic conditions. It is critical that all patients have equal access to health care services independent of age, ethnicity, socio-economic status or health status.




LEADING CHRONIC DISEASES IN LOUISIANA




ACCESS

23% of rural Americans say access to good doctors and hospitals is a major problem, compared with 18% of urbanites and 9% of suburbanites.¹¹



A wave of rural hospital closures in recent years have raised concerns about access to health care. 64 rural hospitals closed between 2013 and 2017, more than twice the number of closures in the previous five-year period.¹¹

PREVENTION AND AFFORDABILITY



5.3% of adults in Louisiana (181,000) have reported an unmet need for mental health treatment, compared to 6.2% nationally¹⁴



8.9% of Louisiana's population is uninsured, compared to **9.2%** nationally¹⁵




14.8% of Louisianans have reported needing to see a doctor but couldn't because of cost, compared to 13.4% nationally 16



Nationally, more than 1 in 3 Medicare beneficiaries spent at least 20% of their income on out-of-pocket costs.

Out-of-pocket spending increased for those in fair or poor health, those with low incomes, and those aged 85+. These costs are expected to rise across the board by 2030.¹⁷
