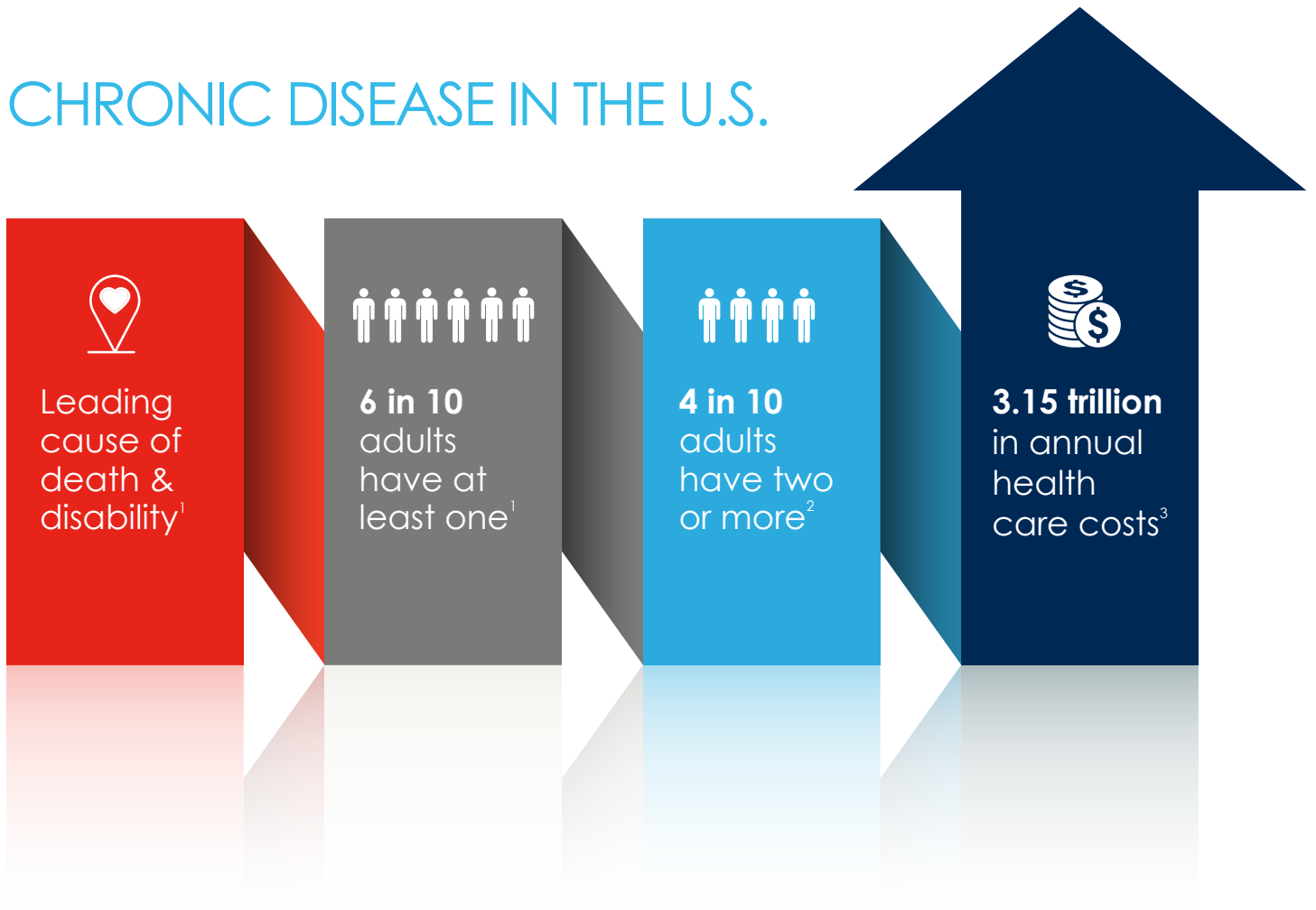

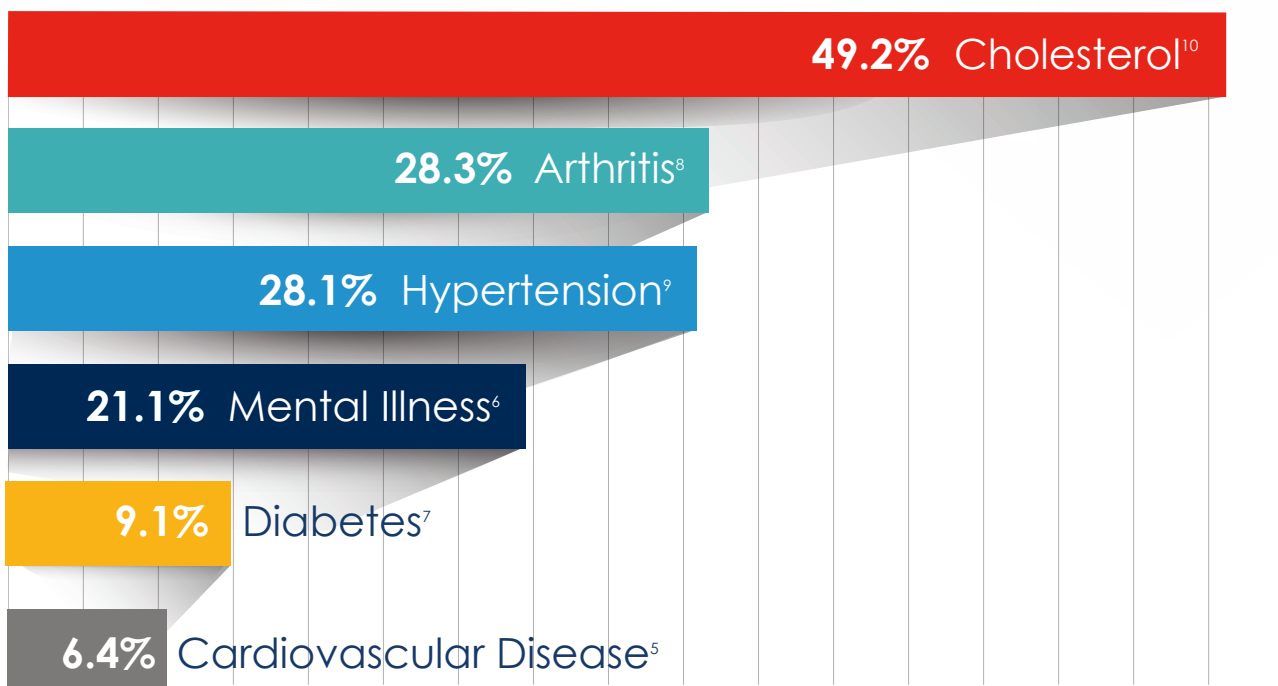

Health care disparities create undue and significant hurdles for patients in need and disproportionately impact individuals with chronic conditions. It is critical that all patients have equal access to health care services independent of age, ethnicity, socio-economic status or health status.

ACCESS

23% of rural Americans say access to good doctors and hospitals is a major problem, compared with **18% of urbanites** and **9% of suburbanites**.¹¹

Rural Americans live an average of **10.5 miles** from the nearest hospital, compared with **5.6** for people in suburban areas and **4.4** for those in urban areas.¹¹

It takes Massachusettsans an average of **13 minutes** by car to travel to the nearest hospital, compared to **13.3 minutes nationally**.¹¹

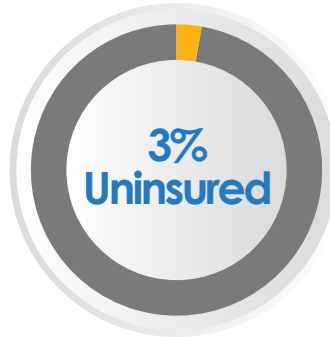
There are **5 Medicare certified rural health clinics**¹³ in Massachusetts, serving more than **98,000** Massachusettsans living in rural areas.¹²

A wave of rural hospital closures in recent years have raised concerns about access to health care. 64 rural hospitals closed between 2013 and 2017, more than twice the number of closures in the previous five-year period.¹¹

PREVENTION AND AFFORDABILITY



6.3% of adults in Massachusetts (343,000) have reported an unmet need for mental health treatment, compared to 6.2% nationally¹⁴



3% of Massachusetts' population is uninsured, compared to 9.2% nationally¹⁵

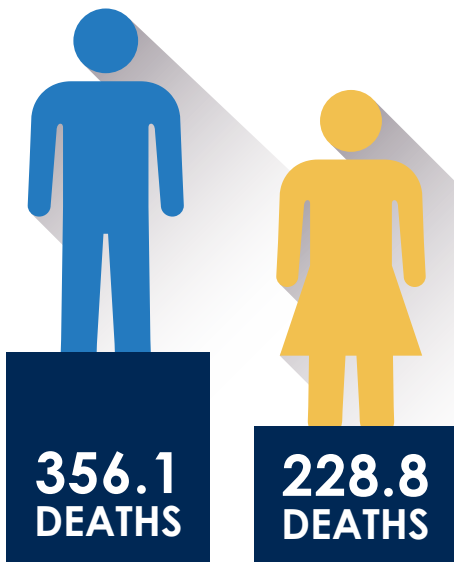


6.8% of Massachusettsans have reported needing to see a doctor but couldn't because of cost, compared to 9.7% nationally¹⁶

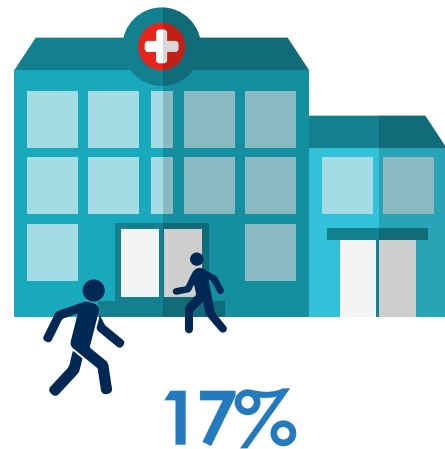


Nationally, more than 1 in 3 Medicare beneficiaries spent at least 20% of their income on out-of-pocket costs. Out-of-pocket spending increased for those in fair or poor health, those with low incomes, and those aged 85+. **These costs are expected to rise across the board by 2030.**¹⁷
