## Members of Congress:

Throughout the country, millions of patients rely on cost-sharing assistance programs, which reduce patient out-of-pocket costs for prescription medications. For many individuals, these cost reductions are significant, allowing them to afford the medications necessary to treat acute and chronic conditions. Without reliable access to these medications, patients will face complications and worsened health outcomes.

On behalf of patients we represent, we strongly oppose recent policy changes in the 2021 Notice of Benefit and Payment Parameters (NBPP) that would allow the exclusion of manufacturer cost-sharing assistance from counting towards patients' out-of-pocket maximums in the commercial market. This policy will prevent patients from accessing the medications they depend upon and create unnecessary barriers to maintaining effective treatment plans, especially during the global Covid-19 pandemic.

Therefore, we urge Congress to pass legislation that would delay the implementation of this rule to at least 2022 and reinstate the limitations on copay accumulators included in the 2020 NBPP to ensure co-pay assistance counts for brand name drugs that do not have a generic alternative. This would allow the Centers for Medicare & Medicaid Services (CMS) additional time to gather stakeholder input on the value of cost-sharing assistance and issue guidance limiting copay accumulators. This will protect patients from the negative impact of this rule during the current public health emergency and allow for a more thoughtful and deliberative rulemaking process to occur in 2022.

When a patient's cost-sharing assistance for the year is exhausted because of an accumulator adjustment program, the patient can face thousands of dollars in unexpected costs at the pharmacy. For patients with chronic diseases who rely on multiple medications to maintain health, this unexpected increase in the costs of their medications could cause patients to discontinue treatment. This is unacceptable.

Due to this rule change, it is expected that many commercial and employersponsored insurance plans will implement or expand the use of accumulator

adjustment programs. The implementation of these programs by insurers and pharmacy benefit managers (PBMs) has already been on the rise, and this rule will eliminate any remaining barrier to prevent insurers from taking this action.

For even the savviest consumer, health insurance plans are complex and difficult to decipher. Therefore, the addition of these accumulator adjustment programs to beneficiaries' existing plans could easily go unnoticed. This is even more likely when they are given misleading monikers, like co-pay protection programs, as has been seen. Therefore, not only will patients face a significant increase in costs, most will have little advance notice of the change and therefore, will have no opportunity to plan for these increased costs.

Further, patients are facing unprecedented risk and hardship during the ongoing pandemic. Many families are experiencing economic insecurity due to lost jobs and for others care has been disrupted due to the country's ongoing response to the coronavirus. This is the worst possible time to further jeopardize the protections and support on which patients rely.

We greatly appreciate your assistance in safeguarding the care that our patients rely upon and ensuring that access to critical medications and treatments is not interrupted. Please quickly pass legislation to delay implementation of this policy and protect access to needed treatments.
